



Sliding Scale for Financial Assistance

The Austin Child Guidance Center strives to serve clients with financial need by offering a sliding fee scale. This metric is used to adjust service fees based on gross household income and family size; regular/standard living expenses are factored into this calculation. The stated percentage represents the percent of service fees qualified clients will be responsible for paying.
