## Sliding Scale Eligibility Criteria

To determine your fee schedule, first find the row that indicates the gross family income of all parent(s)/guardian(s) living in the house with the child client. Then find the column that indicates the number of total people living in the house with the child client. The number on the grid where the row and column meet, is the percentage of the full rate that applies to you.
